ORDINANCE - 129

Information as to Whether a Candidate answers of any question paper of a University examination have been examined and marks are entered will be supplied to the candidate on his forwarding either through the Head of his institution or directly to the University within 14 days from the date of issue of marksheet of the concern examination by the University an application accompanied by a fee of Rs. 40/- for each question paper separately.

The fee is only for verifying whether a candidate's answers in any question paper have been examined and not for the re-examination of the answers. The rule that the marks obtained by the candidates in individual question or in sections of a paper cannot in any circumstances be supplied holds good also in case of the application for the verification of marks. If a result of the verification made under this clause it is discovered there has been either an omission to examine or marks any answer or answers or a mistake in the totaling of the marks. The fee for verification shall be refunded to the applicant.
